8. NON ATTENDANCE / NO SHOW:

Should the company no attend the event for which such agreement has been signed, the deposit for the space reservation will not he refunded. CONTURSA will keep such amount as penalty for damages. In case of force majeure CONTURSA can not hold the event, as asteblished in clause 9 below, or the exhibitor present before the event a recent PCR or similar medical test indicating positive for COVID19 the amount paid to the date will be returned to the same.

9. FORCE MAJEURE

9.1. For the purposes of the COVID-19 pandemic, a cause of force majeure shall be understood to be that which directly makes it impossible or impedes holding the Event in its entirety on the agreed date and which has its origin in the measures taken by the health or governmental authorities or any other competent public administration as a consequence of the aforementioned pandemic. In particular, measures taken by the public authority that directly and completely prevent the Event from being held (i.e. border closures in the case of international events, total confinement, and prohibition of congresses and conferences) shall be considered force majeure.

In addition to the above, "Force Majeure" shall mean the following events: (i) war (whether declared or not), hostilities, invasion, acts of foreign enemies, extensive military mobilisation; (ii) civil war, riots, rebellion and revolution, usurpation - military or otherwise - of power, insurrection, acts of terrorism, sabotage or piracy; (v) plague, epidemic, natural disaster entailing the declaration of a catastrophic zone; (vi) general labour disturbances such as general strike at the national level.

9.2. If any of the causes of "Force Majeure" occur on the date scheduled for the Event, the interested party will inform the other party of such facts as soon as it becomes aware of them. In such a circumstance, if Contursa communicates the suspension of the Event, action will be taken in accordance with the provisions of clause 8 above. Should the date of the Event be postponed to a new date, the amounts already paid by the Company shall remain linked to the Event, in conformity with the updated date. All other terms and conditions of the contract shall remain in full effect.

10. OBLIGATORY INSURANCES:CONTURSA will contract in name of the exhibitor a Damage and a Civil Liability insurance. The cost of both insurances is € 51.20 + Tax. These prices are subject to modifications, according to the current rate of the Insurer.

INSURANCE AGAINST DAMAGE: CONTURSA will contract in name of the exhibitor an All-Risks Material Damage insurance policy, with additional coverage, to assure all goods of any kind or description which are located within CONTURSA site and to which the exhibitor holds title or another assurable interest.

To such effect, the exhibitor must declare to CONTURSA the new-for-old replacement value of all of its goods. However the minimum assured capital will be set in 20.000 €.

NOTE: In case you want to extend the assured capital of more than € 20,000 at first risk, it will be analyzed case by case. The contracted coverage will take effect from the moment the insured goods enter the exhibition site, it will be in effect during the assembly, exhibition and dismantling, and will end when the goods leave the site. In any case, theft of cash is excluded.

DEDUCTIONS: A deductible of the first 500 € is applicable to all claims made under this insurance, except for those covered by the Insurance Compensation Consortium, in which case the deductions specified in the Consortium's regulations will apply,

CONTURSA will contract Civil Liability Insurance policy in the name of the exhibitor as follows:

1.-Period of coverage: from the moment of entry into the exhibition premises, including the erection, until exit from the premises, including the dismantling.

2.-Coverage: the exhibitor's extra-contractual civil liability incurred as a result of its participation in the exhibition, provided that material damages and/or body injury or the prejudice derived from mentioned damage are claimed from the exhibitor.

3.-Insured persons: the exhibitors, the exhibitor's staff and/or their subcontractors. The subcontractors who work for the exhibitors for the erection/ dismantling, must be in possession of Civil Liability Insurance.

4.-Third parties: by principle, all visitors are third parties, as are the owner of the exhibition site, CONTURSA, other exhibitors and their personnel.

5.-Capital: 600.000 € per accident.

6.-Deductions: 500 € per accident.

11.-DATE AND EXHIBIT HOURS

From 5 to 7 February 2022. Day 5 and 6 10:00 h. to 20:00 h. and day 7 l from 10:00 h. to 15:00 h.

12.-STANDS ASSEMBLY

The exhibitors may take possession of their stand from 9:00 hours of February 4th 2022. Assembly of stands may start from this moment and must be completed by 20.00 hours. The timetable for assembly is from 09:00 hours to 20.00 hours without interruption. **Note: Vehicles will not be allowed to enter inside the Pavilions 4th of February.**

13.- DESIGN STANDS ASSEMBLY

The exhibitors may take possession of their space from 9:00 hours of February 3rd 2022. Assembly of stands may start from this moment and must be completed by 20.00 hours on February 4th 2022. The timetable for assembly is from 9:00 hours to 20.00 hours without interruption. The companies that may require more days should ask for them at least 48 hours before and pay the **charge of 335,83 €** per day. **Note: Vehicles will not be allowed to enter inside Pavilions 4th of February 2022.**

14.-STANDS DISMANTLING

Dismantling of stands will start on 7th February 2022 from 15:00 to 20:00 and 8th February 2022 from 9:00 to 14:00 hours.

15.-ASSEMBLY FEE FOR DESIGNED STANDS

The exhibitors who want to assembly their own stand approved by the organisation, must pay an amount of **3,70 €/sq.mt.** + vat tax before the stand assembly starts.

16.- RULES-KIT FOR ALL STANDS

For the set up and dismantling of design stands and decoration of modular stand, the rules-kit, whose content is declared known and accepted by the contractor, will be applied. You can find the rules-kit on <u>www.fibes.es</u>

17.- QUALITY

The organizing company must comply at all times with the conditions required by CONTURSA regarding Quality standards, compying with set-up and dismantling schedules arranged and agreed on by the parties involved. If a complaint related to the organization of said event is received, the complaint will be communicated from the Quality Department for its correct management.

18.- CRIME PREVENTION PLAN AND ETHICAL CODE OF CONDUCT

The participating company commits to acting in accordance with Contursa's Ethical Code of Conduct, which it declares to know and accept, in addition to complying with current legislation and specific agreements reached for the performance of its activity as a participant.

In this regard, the participating company is informed that Contursa has enabled a Complaints Channel, through which they can report bad practices, breaches or possible risks of non-compliance with the Ethical Code, any action carried out by workers or managers of Contursa in their relationship with the participating company, available through the following link: https://www.fibes.es/compliance/procedimiento-de-canal-de-denuncia/

19.- COVID-19 ACTION PROTOCOL

The participating company is aware of the <u>COVID-19 Protocol/Guideline of Contursa</u>, drawn up in accordance with the measures approved by the competent public administrations to prevent COVID-19 infection, and undertakes to comply with the requirements and recommendations indicated therein. The parties agree to take all necessary steps to establish a safe and secure environment for Expobelleza Andalucía.

The participating company will be informed of any modification to the Protocol, as a result of changes or the approval of new measures issued by the public administrations that affect the organisation of Expobelleza Andalucía.

20.- ENVIRONMENT

The contractor company must comply at all times with the conditions required by CONTURSA regarding the Environment, which include caring out the correct separation of waste to which aim the different containers placed at CONTURSA's facilities must be used, ensuring proper Environmental management. If dangerous waste is generated, it must be managed by the company itself, providing legal documents proving its proper Environmental management.

21.-MODIFICATION OF THE SPACE CONTRACTED

The spaces contracted are indivisible, however, if after contracting the space the Exhibitor request a reduction of the space, he would lose the position initially contracted but he could choose between the spaces available at that time. In the event the Exhibitor cancels its participation on the fair for this particular reason, the deposit for the space reservation will not be refunded.

22.- LAW PROTECTION OF PERSONAL DATA
